Introduction and Background:

In October 2014, the Planning and Zoning Board recommended that two sections of land within the Princeville town limits be rezoned as follows: **1)** A triangle-shaped section along Greenwood Ave. with the approximate coordinates of 35.89074, -77.51047 to 35.88928, -77.51072 to 35.88855, -77.50561 that is now zoned 'R-2'. This section would be rezoned to 'R-1'. **2)** A parcel owned by Three Evans Inc. which is known as Forest Haven Mobile Home Park (PIN 4737-79-6080) that is now zoned 'R-1'. This section would be rezoned to 'R-2'.

A properly advertised public hearing was held on October 27, 2014 during the regular meeting of the Princeville Board of Commissioners and all affected property owners of record were notified of the potential changes in zoning classification by first class mail. The Board of Commissioners tabled the recommendation during the November 2014 regular Board meeting. On March 12, 2015, the Planning Board voted to ask the Board of Commissioners to reconsider the recommendation.

Recommendation:

At the Board's discretion, the recommendations by the Planning and Zoning Board can be adopted and zoning classifications of the two sections can be amended as-presented.

Introduction and Background: In order to continue participating in the National Flood Insurance Program, the Town must adopt a new flood damage prevention ordinance and must adopt new flood maps. Prior to adoption, the Town must hold a properly advertised public hearing. The public hearing was advertised on March 11 and 18, 2015 in the Edgecombe Tribune and a copy of the ordinance and maps has been available for view at the Town Hall. In the past, Princeville has had an agreement with Edgecombe County whereby the County enforces flood prevention measures in the Town of Princeville. This agreement will continue with Princeville adopting Edgecombe County's ordinance and maps (the ordinance will be identical to the one presented during Princeville's public hearing).
