Introduction and Background: The Town has expressed a desire to upgrade the facilities at Heritage Park. Some of the ideas which have been discussed include walking trails, adult exercise facilities, shelters, a band stand, upgrades to the athletic fields, etc. The UCPCOG has been very successful in applying for PARTF grants which are specifically geared towards parks and recreation. The UCPCOG has presented a proposal to the town to prepare and submit a 2015-2016 NC Parks and Recreation Trust Fund Grant. Compensation for these services will not exceed \$8,500.

Recommendation: Authorize the Mayor and Town Manager to execute the contract as presented and approve the preparation of the PARTF Grant as proposed by the UCPCOG.
