4) Public Comments: Elaine Dancy: Asked about Robo Calls and why they stopped because she wasn't getting any Information. The Town Manager shared that she would follow up as she too thinks that resuming the calls would be ideal. Atty Jones supported the Robo calls.

- A) Board approved for the playground equipment to be installed by Miracle and it was shared that it is estimated to take 4-6 weeks to include installation, mulch and removal of old equipment. A turnkey project (4-0) Commissioner Joyner motioned and Commissioner Bullock seconded.
- B) Board approved the work to be done at the Museum, Senior Center and Construction Administrator by Oakley Collier and will await the contract (4-0). Commissioner Myrick motloned and Commissioner Bullock seconded.
- C) 53 Acres is planning a workshop for the community on the 28th and 29th to share the results of the 53 acres. They are also planning a working session

- with key stakeholders in prep for the meeting with citizens. It will be at 6pm at the Administration building by the S&ME team.
- D) Hazard Mitigation Grant Program (HMGP) will conduct the feasibility study and the County is prepared to sign the contract while coordinating a RFP for at least two engineers to conduct the study,
- E) Turner Prince Job Training Initiative: A program off the heels of Rescue 7other companies working in Princeville will join the initiative. Mr. Charles Wright was available to answer a few questions and noted that the 20 hours would be paid. He also shared that collaboration has transpired with Edgecombe Community College.
- F) Law Enforcement Agreement. The Board approved hours from 7:00pm to 3:00am on Friday and Saturday at \$25.00 an hour. The Town Manager will produce the contract incorporating the Board's desire. Commissioner Myrick inquired about the comparison report. The Town Manager stated that the Sheriff shared that the monthly reports provided was for only Princeville and not Edgecombe County. Commissioner Joyner asked if a report could be sent of Edgecombe County vs Princeville. The Town Manager stated that she would inquire with the Sheriff.
- G) Signage update: NCDOT did not approve the seal to be on the welcoming signs as it's not permissible within Town under 45 miles per hour (copy of email provided). But the welcoming would be allowed. The Board approved the updated based on NCDOT policy and procedure (4-0). Commissioner Myrick motioned and Commissioner Bullock seconded.
