- V. Public Hearing: Mayor Pro Tem Alvin Jones motioned to open the Public Hearing seconded by Commissioner Milton Bullock, Motion carried 4-0. The public hearing is to address the proposed 2023-2024 budget. Motion to approve Proposed budget for 2023-2024 by Commissioner Bullock seconded by Mayor Pro Tem Jones. Voted Carried 4-0. Budget Ordinances motion to approve by Mayor Pro Tem Jones, seconded by Commissioner Linda Joyner. Vote Carried 4-0. Motion to approve all budget amendments. Motion to approve by Commissioner Linda Joyner seconded by Mayor Pro Tem Alvin Jones. Vote carried 4-0.

X. Department Reports (See Attachments)

- 1. Finance Reports (Check detail & Debit Card): Commissioner Myrick had questions concerning reference number 3050 in the amount of \$ 244.07 to Edgecombe water and sewer. He indicated we may need to check for leaks at the senior center or town hall. They should not be using that much water in a month. The Town Manager indicated that she would check into it and send the results to the board members. Also, Commissioner Myrick reference number 3023 in the amount of \$300.00. Town manager indicated that was for door prizes for Elevate Edgecombe where receipts were returned. Commissioner Myrick had questions regarding payment to Tar Heel Heating and Air. The Town Manager indicated that the air conditioner was not working properly at the Senior Center. Tar Heel Heating and Air discovered there was a problem with the drainage switch that needed to be repaired. Commissioner Myrick asked if the air conditioner was under warranty. The Town Manager explained that it expired the last time Burney and Burney came to complete repair with the manufacture warranty. However, there is a warranty in place on the current repair.

1. Senior Center: The Senior Center received an increase in funding from United Way. Ms. Tate and Town Manager also applied for a grant through the Edgecombe Aging Program. We are continuously trying to get the elevator working. We are making sure we have all the entities in place at the time of the inspection. Commissioner Myrick inquired about survey for the tree on first street. Commissioner Myrick inquired about Prince Court. Town Manager indicated that nothing changed since the last report the owner is still wanting to sale.

XIII. Old Business

1. ARP Updates the Youth Academy will be running from now until August. The amount for the ARP funding left after the Elevate events is roughtly190,000.00. and there remain other invoices that have not been paid. Town Manager shared that 10,201.98The Town only had one group to apply to be contractors. We will be extending bids until July 14, 2023, at noon. Mayor Pro Tem asked what can be used for the housing and Academy, asked the Town Manager for recommendation. Town Manager recommended that the Board assess from the balance how much should go to the Academy and keep in mind that the last round of housing repair applications might not receive the amount that the first group did because of what been used since.

2. OSBM Funding Town Manager shared a document from OSBM. Via Amendment #8 of

remaining balances.

3. Farmers Market: The Town did receive based upon the bids. Wooten is recommending Weaver and Asphalt. Motion to approve by Commissioner Bullock. Seconded by Mayor Pro Tem Jones. Vote Carried 4-0.

2. Amended Contract for Audit (Recommendation Approval) Mayor Pro Tem motioned for

approval, seconded by Commissioner Bullock. Vote carried 4-0.

3. Princeville Hall of Fame Town Manager shared the vision. The Mayor responded that he thought that it was a great idea. Town Manager shared that Mr. Jarvis Pettaway brought it to her attention. No questions from the board.

XV. Board Comments: Commissioner Myrick thanked the citizens for taking the time out of their busy schedules to attend the board meeting.
