VIII. Presentation

- 1.Resolution (Commissioner Joyner) Commissioner Joyner presented August 5 as a day to recognize hometown hero, Mr. Carter Ray Suggs Day. Mr. Carter Ray Suggs was a pillar in the community, and he helped and touched so many people. Mayor Jones read the resolution and presented it to the late Carter Ray Suggs sister, Catherine Suggs.
