Public Comments:

James "Ed" Bridgers 402 Otis Avenue: Said since 2015 he has been asking the Town to bring the police department back. He said he would gather a petition if the board does not honor the citizen's request to bring the police department back.

Commissioner Bullock made a motion to start public hearing for the PARTF Grant; **Commissioner Myrick** seconded; motion passed **(4-0)**

Tirence Horne/Steve Moler, Upper Coastal Plain Council of Gov't: gave a presentation for the PARTF Grant.

Delia Perkins: Does not want the Town to obligate funds to renovate a park until the Town obligate funds for a Police Department.

Linda Worsley, Senior Center Director: said the park plans looks good and that she would love for the park to be updated, but the Town does not need to work on renovating Heritage Park until the Town establishes a Police Department.

Senior Center Report: Linda Worsley, Senior Center has visited Rocky Mount and surrounding areas. The United Way told her that the center needs an Advisory Board/Committee to apply for grants. In addition, she stated the van that they use to travel has around 175,000 miles on it and it may last another 2 to 3 months because of its condition. She also wants to start a garden with the senior citizens and that the Life Center of Conetoe Baptist would like to help them. Rural Development told her that they might be able to help find a van, if the Town was willing to go in on it.
